MEMORANDUM FOR Parks Reserve Forces Training Area and BT Collins Soldier's Families, DA Civilians, Contract Personnel, and Tenant Units

SUBJECT: PRFTA Policy #5, Dress Code Policy for Parks Reserve Forces Training Area and BT Collins Dining Facilities (DFAC's).

- 1. REFERENCE. AR 670-1, Wear and Appearance of Army Uniforms and Insignia, 3 February 2005.
- 2. PURPOSE. To provide guidance to Parks Reserve Forces Training Area (PRFTA) Soldiers and Civilians on the dress code while dining in the PRFTA and BT Collins dining facilities
- 3. APPLICABILITY. This policy is applicable to Soldier's Families, DA Civilians, Contractor Personnel (in possession of DoD CAC cards), and Tenant Units.

4. POLICY.

- a. Headgear will not be worn in the dining facility unless an individual is "under arms" in an official capacity, IAW AR 670-1, para 1-10 K (2).
- b. Weapons are authorized in the dining facility. Weapons must be properly cleared, magazine removed, and selector lever on SAFE prior to entering the facility. Weapons will be holstered (in the case of handguns), or placed between their legs, muzzle facing down. Positive control of the weapon will be maintained at all times.
- c. Authorized military and Civilian clothing will not be mixed. Military uniforms will be worn in accordance with appropriate service regulations. Physical Fitness uniforms (PFU) are allowed but must be generally clean and not excessively wet.
- d. Undergarments will not be worn as outer garments. Rollers, shower caps and pin curls are not allowed. Excessively revealing tank tops/sleeveless shirts may not be worn.
- e. Clothing that is ripped or soiled that presents an unhealthy or unclean appearance is not allowed in the dining facility.
- f. Shirts must be worn at all times. Shirts must cover armpits and body torso. Shirts must not display profanity or obscene sketches, pictures, or remarks.

- h. The Food Program Manager (FPM), Quality Assurance Evaluator (QAE) or contracting officer's representative (COR) may refuse service to personnel dressed in an extremely offensive manner or excessively unclean.
- i. Field gear, back packs/book bags, unit Guide-ons, etc. will be stored on the hooks provided near the sign in sheet.
