C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on information from the October 2012 delineation report and October 11, 2012 site visit by Cathy Juhas, Oxbows 1 and 2 are isolated. No boating or irrigation would be possible at any location within these wetlands, no fisheries are present, and there is no interstate or foreign commerce at these sites.

Oxbow 1 includes a 0.74 acre temporarily flooded palustrine emergent wetland located at Station 306+07 west of O'Fallon Creek at the southwest end of the project area. This wetland appears to be an old oxbow channel that was created by a natural channel avulsion in O'Fallon Creek. The wetland is located within a higher, abandoned floodplain feature that is hydrologically disconnected from the current channel. The source of hydrology for this wetland is precipitation, because the wetland is perched and disconnected from the O'Fallon Creek channel.

Oxbow 2 includes a 0.54 acre temporarily flooded palustrine emergent wetland located at Station 300+00 east of O'Fallon Creek at the southeast end of the project area. This wetland appears to be an old oxbow channel that was created by a natural channel avulsion in O'Fallon Creek. The wetland is located within a higher, abandoned floodplain feature that is hydrologically disconnected from the current channel. The source of hydrology for this wetland is precipitation, because the wetland is perched and disconnected from the O'Fallon Creek channel.

Oxbow 3 exhibited no wetland characteristics.

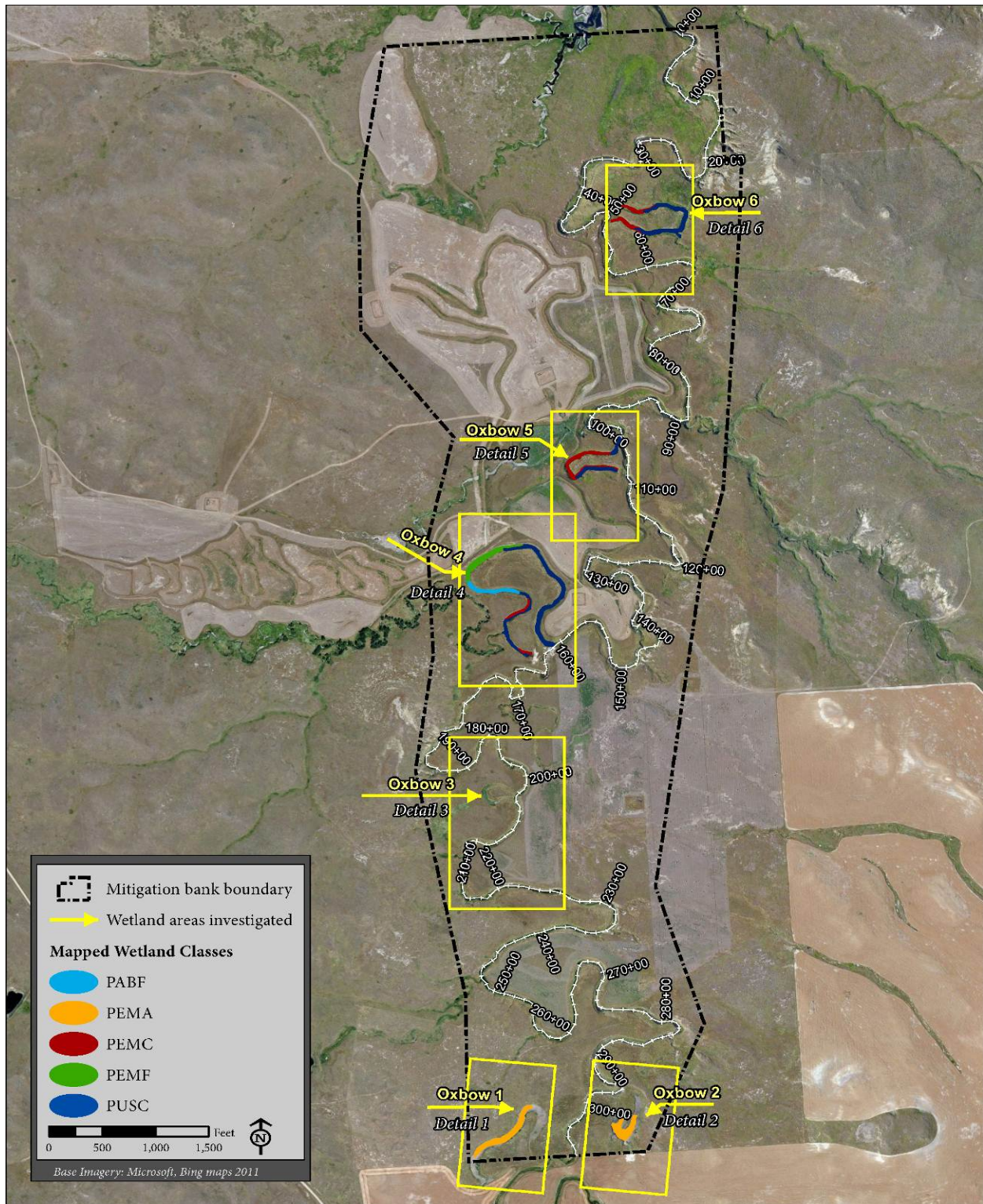


Figure 1: Overview of wetlands included in the Ringling Ranch Delineation
