Ramadan is the month in which Muslims believe the Koran was revealed to the Prophet Muhammad, beginning with a simple word – iqra. It is therefore a time when Muslims reflect upon the wisdom and guidance that comes with faith, and the responsibility that human beings have to one another, and to God.

Like many people of different faiths who have known Ramadan through our communities and families, I know this to be a festive time – a time when families gather, friends host iftars, and meals are shared. But I also know that Ramadan is a time of intense devotion and reflection – a time when Muslims fast during the day and perform tarawih prayers at night, reciting and listening to the entire Koran over the course of the month.

## Remarks to State "Turkmenistan" TV by Under Secretary of State for Political Affairs William J. Burns

*QUESTION*: What are the main directions of future cooperation between the new administration of President Obama and Turkmenistan?

UNDER SECRETARY BURNS: It's a pleasure to be in Turkmenistan with our delegation from Washington. We had very productive talks. We've agreed with our partners in Turkmenistan to set up a new bilateral forum or commission, a mechanism through which we can seek to make further progress in relations across a wide range of issues, including cooperation in economic development, in the energy sector, and in ways in which we can work together on Afghanistan and on our common interest in stability there. We can work together to combat the problems of narcotics and terrorism. And we can develop ties between our civil societies and build stronger cooperation in education, culture, as well as establish a dialogue on human rights issues. So again, I am very appreciative of the hospitality of the President and Foreign Minister and I leave convinced that there is considerable potential for the further strengthening of relations between our two countries.

QUESTION: Recently there was a visit of Turkmen Foreign Minister to the United States. Can we consider your visit as a reply visit? And could you tell us about issues you considered at your meeting with Foreign Minister today?

UNDER SECRETARY BURNS: Foreign Minister Meredov paid a very successful visit to Washington and certainly our visit to Ashgabat is an opportunity to build on that success. And today we had an opportunity for very thorough discussion of the range of issues in our relationship, ways in which we can establish this forum or commission that I've described before and ways in which we can work together and take practical steps forward in the interest of both the United States and Turkmenistan. Thank you.

## **U.S.** Government Donates Vehicles and Counter Narcotics Equipment to Turkmenistan

The U.S. Embassy held a ceremony on August 6, to

on August 6, to formally deliver two TOYOTA-Corolla vehicles and 20 narcotics identification kits (NIK) to the State Counter Narcotics Service of Turkmenistan. The donation is part of the Embassy's

International Narcotics and Law Enforcement Program. The U.S. Embassy's, stated at the ceremony: The system of narcotics identification was developed as a means to rapidly screen and presumptively identify illicit drugs in the field. In 2007, the Embassy also donated two VAZ 21102 vehicles, a Gas Chromatograph with Flame Ionization Detector and a Fourier Transform Infrared Spectrophotometer to the National Criminal Research Center of Turkmenistan's Ministry of the Interior. In March 2006, the Embassy signed the first Amendment

to the Letter of Agreement between the Government of the United States and the Government of Turkmenistan on Narcotics Control and Law Enforcement Assistance. That amendment provided for additional USG assistance projects designed to improve the ability of Turkmenistan's counternarcotics forces to interdict narcotics in transit across Turkmenistan. The Embassy's International Narcotics and Law Enforcement Program has been conducting training, providing special laboratory equipment, and sending Turkmenistan's forensic scientists to international meetings.

# **Interview with William Stevens New Public Affairs Officer**

QUESTION: When did you arrive to Turkmensitan?

WILLIAM STEVENS: I arrived in Ashgabat in early August 2009 and plan on being here for the next three years.

*QUESTION*: What were your expectations about the country and people prior to your arrival? Have those expectations changed?

WILLIAM STEVENS: I have to admit I didn't have very many expectations about Turkmenistan before I arrived. I am an avid student of history and spent a lot of time study-

ing the history of this region and knew of the proud reputation of the Turkmen before and during the Russian conquest in the late 19th century. However, during my years in Russia and other former soviet countries, I hadn't met many Turkmen. When I told my Russian friends about my trip, most of them talked about the great Turkmen dinya and arbuz.



I knew that Turkmenistan was a country rich in natural resources, culture, and history. I've already started studying Turkmen and I hope that during my time here I'll be able to learn the language and more of your history and the rich culture that permeates this society.

I should add that since my arrival I've been overwhelmed by the kindness and generosity of the Turkmen people.

## Cooperation – Tool for Improvement of Vocational Training

On August 26, the U.S. Agency for International Development's (USAID) Turkmenistan Community Empowerment Program (TCEP) organized a meeting on youth vocational training issues in partnership with the Union of Entrepreneurs and Industrialists. Participants, including government officials, teachers, vocational school graduates from four provinces, and representatives of the European Union's TEMPUS Program and Turkish International Cooperation and Development Agency (TIKA), discussed the project's achievements related to youth vocational training and the promotion of youth economic activities in rural areas.

The meeting also focused on the importance of cooperation between vocational establishments and employers in order to upgrade the level of training and update their curricula to meet current labor market demands. Participants emphasized that youth vocational training plays an important role in supporting the stated national priority of training highly professional specialists that can contribute to a dynamically developing national economy. Youth that have gained solid vocational skills will be a valuable workforce for rural development. The young people noted that high-quality training in demand-driven specialties was a guarantee of social and economic stability and confidence in the future.

The Turkmenistan Community Empowerment Program, implemented by Counterpart International, is one of the many activities made possible by the American people through the United States Agency for International Development (USAID). Since 1993, the American people through USAID have provided more than \$80 million in programs that support Turkmenistan's economic growth, social sector, and community initiatives.

These rituals remind us of the principles that we hold in common, and Islam's role in advancing justice, progress, tolerance, and the dignity of all human beings.

This summer, people across America have served in their communities – educating children, caring for the sick, and extending a hand to those who have fallen on hard times. Faith-based organizations, including many Islamic organizations, have been at the forefront in participating in this summer of service. And in these challenging times, this is a spirit of responsibility that we must sustain in the months and years to come.

Beyond America's borders, we are also committed to keeping our responsibility to build a world that is more peaceful and secure. That is why we are responsibly ending the war in Iraq. That is why we are isolating violent extremists while empowering the people in places like Afghanistan and Pakistan. That is why we are unyielding in our support for a two-state solution that recognizes the rights of Israelis and Palestinians to live in peace and security.

All of these efforts are a part of America's commitment to engage Muslims and Muslim-majority nations on the basis of mutual interest and mutual respect. And at this time of renewal, I want to reiterate my commitment to a new beginning between America and Muslims around the world.

As I said in Cairo, this new beginning must be borne out in a sustained effort to listen to each other, to learn from each other, to respect one another, and to seek common ground. I believe an important part of this is listening, and in the last two months, American embassies around the world have reached out not just to governments, but directly to people in Muslim-majority countries. From around the world, we have received an outpouring of feedback about how America can be a partner on behalf of peoples' aspirations.

We cannot change things over night, but we can honestly resolve to do what must be done, while setting off in a new direction – toward the destination that we seek for ourselves, and for our children. That is the journey that we must travel together.

I look forward to continuing this critically important dialogue and turning it into action. And today, I want to join with the 1.5 billion Muslims around the world – and your families and friends – in welcoming the beginning of Ramadan, and wishing you a blessed month. May God's peace be upon you.
