SUBJECT: Fort Hood Flight Safety and Standardization Committee (FHFSSC)/Garrison Airfield Operations Board (AOB) Minutes for the 1st Quarter, FY 12

1. OPENING COMMENTS: The meeting was opened at 1000 by CW5 Green and COL Hersey welcomed all present.

2. OLD BUSINESS:

ISSUE: Sling Load Weights

\$20,000±10% with a build completion time somewhere in February 2011. The UH-60 community requested another weight be added for hoist operations training. Ron Deshotel agreed to get another estimate for this weight and contact CW5 Green with the new numbers. COL Lamb reviewed and determined that besides yet another delay in construction, the final estimate is already several thousand dollars over the initial estimates and is at the limit of the funds that the 21st Cav Brigade has made available for the project. Ron Deshotel has been given the green light to engage the contract. As carried over from the last meeting, Ron Deshotel reported that there have been issues with 2 stainless steel suppliers and he can find no one in the state that can build the hardware to spec. He is currently attempting to find out how Ft. Rucker, Ft. Bragg, and Ft. Campbell obtained their weights and whether or not the weights at these installations actually meet spec. **OPEN**

STATUS: Still working. OPEN

3. NEW BUSINESS:

a. ISSUE: DOL is using Helipad 27 as a storage container pad and requested it be closed.

DISCUSSION: Helipad 27 was used to land aircraft that were bound for the paint shop vicinity of DOL. For years the paint shop has been at HAAF and Helipad 27 has not been used except for its annual safety inspection. DOL is currently using the Helipad as a storage area for storage containers and requested it be closed.

STATUS: No one present objected to the helipad closure so a NOTAM will be issued to indicate its closure. **CLOSED**

b. ISSUE: COL Hersey inquired about the completion of the FH 95-1.

DISCUSSION: Bob Ulrigg answered that there was a formatting issue with the regulation and so it had to be rewritten.
