SUBJECT : FINANCIAL STATUS REPORT (SF-269) FOR FISCAL YEAR
1990

CONTENT : During Fiscal Year 1990, State vocational rehabilitation (VR) agencies were awarded \$1,524,677,000 in Federal funds under Section 110 of the Rehabilitation Act of 1973, as amended, to provide rehabilitation services to persons with disabilities. An analysis of the year-end SF-269s indicates that State VR agencies obligated \$1,524,119,280 2/ of the total amount awarded.

Six State VR agencies reported unobligated balances totalling \$1,213,979. Of that amount, \$656,259 was transferred from North Carolina Blind Agency to North Carolina General Agency. Therefore, upon receipt of the subsequent SF-269s, the total U.S. unobligated balance will be reduced to \$557,720. Of the total unobligated balance, \$5,858 was from unused reallocated funds.

Attached is a table showing State agencies that reported unused Federal funds on their SF-269 year-end reports for Fiscal Year 1990.

State VR agencies spent \$452,491,095 in State funds. The total amount of Federal and State funds expended for Fiscal Year 1990 was \$1,976,610,375 2/.
