SUBJECT: FIRST REALLOTMENT FOR THE BASIC SUPPORT PROGRAM –

FY 2000

CONTENT: A decision has been made to reallocate funds released in the first reallotment only to those States whose FY 2000 annual allotments fell below their FY 1999 allotments. In addition, funds that may be released in subsequent FY 2000 reallotments will also be provided to the same six States, to the extent of their FY 2000 shortfalls. States that fell below the FY 1999 level of funding in FY 2000 and their corresponding shortfalls in FY 2000 are as follows:

A total of \$1,351,277 was released for reallotment (\$1,096,784 by Wyoming and \$254,493 by Guam).

Please find attached your grant award for the first reallotment for the Basic Support Program, **if** your agency relinquished funds during this reallotment or if your agency is one of the six States that fell below its FY 1999 funding level in FY 2000.

The second reallotment under the Basic Support Program is scheduled for September 19, 2000. State Agencies are reminded to inform their

respective RSA Regional Offices by August 25, 2000, as to whether they are relinquishing or requesting additional funds, or not requesting a change to the most current grant award level.
