SUBJECT: Dissemination of the publication entitled: "Effective Strategies for Improving Employment Outcomes for People with Chronic Kidney Disease," developed by the Twenty-Seventh Institute on Rehabilitation Issues (IRI).

CONTENT: The purpose of this Information Memorandum (IM) is to transmit the enclosed publication to vocational rehabilitation (VR) professionals, advocates and other stakeholders in the public VR program. The publication was developed by individuals representing various State VR programs, the Regional Rehabilitation Continuing Education Programs (RRCEPs), Rehabilitation Services Administration (RSA), and other healthcare and advocacy programs for persons with chronic kidney disease (CKD). Ms. Jeanne Miller, the Director of the RRCEP VI at the University of Arkansas, served as the university coordinator for the study group.

The intent of this document is to assist VR administrators, counselors, and consumers of rehabilitation services in understanding how persons with CKD can be assisted in achieving employment. The publication is a source of innovative ideas for rehabilitation personnel, and a manual to use in training staff.

This document was necessary to counter the many myths that have proliferated about persons with CKD, and to lead to a better understanding and working relationship between the rehabilitation and renal communities. The myths range from "dialysis clients are too sick and unstable to work and will die soon," to "people with CKD who are working or who have had a transplant don't need and aren't eligible for VR services." The fact is that people on dialysis, or who have had successful transplants, are still living after more than 30 years. The clear message is that people with CKD are fully able to participate in America's workforce.

IRI publications are widely used by VR counselors and supervisors, human resource development specialists, consumers, community-based rehabilitation service providers, administrators, researchers, educators and policy analysts in fulfilling the purposes of the Rehabilitation Act, as amended, particularly, "... to empower individuals with disabilities to maximize employment, economic self-sufficiency, independence, and inclusion and integration into society..."
