SUBJECT: "RETIREMENT" OF POLICY ISSUANCES

BACKGROUND: On September 23, 1990, the Rehabilitation Services Administration (RSA) announced a new System for Issuing Policy and Information (SIPI), transmitted by RSA-IM-90-44, dated September 28, 1990. As part of RSA's policy reform, policy issuance have been examined and analyzed for currency and retiring. The review, assessment, and refinement of RSA issuances have continued and produced a significant number of issuances for rescinding. Earlier notices regarding retirement, verification, or reinstatement of RSA issuances were transmitted by RSA-PPD-89-03, dated March 10, 1989, RSA-PD-91-04, dated January 11, 1991, and RSA-IM-91-13, dated February 22, 1991.

POLICY

STATEMENT: The purpose of this issuance is to identify those policy issuances that are outdated or otherwise need to be "retired". Effective immediately, the attached policy issuances are "retired" for the reasons indicated in the accompanying list. As of the date of this directive, the listed issuances are not considered to have any force or effect for purpose of administration of the Rehabilitation Act, as amended, or of the Randolph-Sheppard Act.
