SUBJECT: **Reenlistment Options for Specific Commands**

1. Reference:

- a. AR 601-280, Army Retention Policy, 31 January 2006
- b. Policy Message 11-02 (with Changes)

2. **The Regular Army Reenlistment Option, (E-1); is only available**, if otherwise qualified, to those **Soldiers serving in a balanced (N/N) MOS** in the commands listed below who have a **contractual ETS date on or before 30 September 2011**. **Minimum reenlistment term length is 3 years**. This applies to all categories.

Note: When referring to AR 601-280 Policy Message 11-01 para 4-2d and 3-6b, in which it states 2 years, this policy super cedes and those balanced listed below must reenlist for 3 years.

- a. **AMC** ( MACOM Code: X1, X2, X3, X5, X6, X7, X8, XB, XC, XD, XK, XP, XQ, XR, XT, XX )
- b. **ARCENT** ( MACOM Code: 3A )
- c. **ARSOUTH** ( MACOM Code: 6A, SU )
- d. **ATEC** ( MACOM Code: AT )
- e. **CIDC** ( MACOM Code: CB, SE)
- f. **EUSA** ( MACOM Code: P8 )
- g. **FORSCOM** (MACOM Code: FC, FZ)
- h. **IMCOM** (MACOM Code: BA)
- i. **MEDCOM** ( MACOM Codes: E1, E5, MC )
- j. **TRADOC** ( MACOM Codes: AA, AP, TC )
- k. **USAREUR** ( MACOM Codes: E1, E2, E3, E5, EC, EN, ER )
- l. **USMA** ( MACOM Code: MA )

3. **Under strength (Y/N)** Soldiers **who have a contractual ETS date on or before 30 September 2011** are eligible for options IAW Policy Message 11-02 (with changes).

4. **Over strength (N/Y)** Soldiers who have a contractual ETS date on or before 30 September 2011 will receive options as prescribed in Policy Message 11-02 (with changes). Over strength (N/Y) Soldiers on assignment and require to meet the Service Remaining Requirement are authorized to reenlist for a period not to exceed 2 years, under the Regular Army Reenlistment Option (E-1). Refer to AR 601-280, Policy Message 11-01 para 4-2d and 3-6b.

5. **The Regular Army Reenlistment Option, (E-1); is only available**, if otherwise qualified, to those **Soldiers serving in a balanced (N/N) and under strength (Y/N) MOS** in the commands listed below who have a contractual **ETS date on or before 30 September 2012**. **Minimum reenlistment term length is 3 years**. This applies to the **Initial Term category**.

a. **EUSA** (MACOM Code: P8)

b. **MEDCOM** (MACOM Codes: E1, E5, MC)

c. **SMDC** (MACOM code: SC)

6. **The Regular Army Reenlistment Option, (E-1); is only available**, if otherwise qualified, to those **Soldiers serving in a balanced (N/N) and under strength (Y/N) MOS** in the commands listed below who have a contractual ETS date **on or before 30 September 2012**. **Minimum reenlistment term length is 3 years**. This applies to the **Mid-Careerist category**.

a. **MEDCOM** (MACOM Codes: E1, E5, MC)

b. **TRADOC** (MACOM Codes: AA, AP, TC)
