C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The hydrology on the site has been manipulated to accommodate development. Existing drainages have been re-routed into concrete-lined channels, resulting in straight channels as opposed to natural, meandering channels (See soil_survey.jpg).

WUS-3 is a channel with an ordinary high water mark and defined bed and bank that has been lined with concrete in the uppser 2/3 of the channel. The bottom 1/3of the channel is not concrete-lined. WUS-3 has been mapped by the USFWS National Wetlands Inventory as PEMCx linear wetland.

All wetlands (WL-2, WL-3, WL-4, WL-5, WL-6) are abutting the channel Wetlands provides habitat for small mammals, reptiles, insects, and plants. Acts as a sediment and contaminant trap; filtering water prior to entering Oak Creek. Segment of WUS-3 is listed as a Category IV Saline Wetland (sig_nex.jpg). Oak Lake, which is adjacent to Oak Creek, is listed as a TNW and a Category I Saline Wetland. The channel and wetlands enter Oak Creek, which enters Salt Creek; a TNW.

Water flows to the south into Oak Creek. Oak Creek flows into Salt Creek, which flows into the Platte River, which flows into the Missouri River. The channel exhibits sufficient flow, duration, and volume to transport sediment and contaminants at a frequency and manner that confirms this system has the capacity to have more than a speculative affect on the chemical, physical, and ecological integrity of the unnamed tributary (RPW), Oak Creek (RPW), Salt Creek (TNW), Platte River (TNW), and the Missouri River (TNW).
