adjacent agricultural land. There is no evidence of a connection between the wetlands and other waterbodies, i.e. no evidence of hydrology or wetland vegetation. The wetlands do not receive flow from a jurisdictional water body nor do they discharge flow into a jurisdictional water body. The wetlands are approximately 2 miles from a tributary to Lodgepole Creek (a relatively permanent water of the U.S.) and approximately 30 miles from the South Platte River (a traditional navigable water of the U.S.). There is no evidence to support a hydrological connection between these areas and a water of the U.S. No interstate commerce is present, nor is there any evidence to show that the wetlands 1) are or could be used by interstate or foreign travelers for recreational or other purposes, 2) produces fish or shellfish which are or could be taken and sold in interstate or foreign commerce, or 3) are or could be used for industrial purposes by industries in interstate commerce.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
