**2. Non-regulated waters/wetlands (check if applicable):<sup>3</sup>**

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **This JD review area is a tributary to a Rainwater Basin wetland, approximately 1,250 acres in size. This channel is one of four that feed the basin. The road ditches have been over-excavated and concentration pits have been excavated within the wetland. The old-timers claim that a drain tile was installed many years ago to try to drain the basin. Over the years, the tile line collapsed after which someone deepened a road ditch connecting the wetland drainage to a stream channel. Surface water does not flow through the road ditch, however, the bottom of the ditch is a wetland for at least 1/2 - mile. The channel is then impounded by a dam. There is a culvert in the dam but no apparent channel or wetlands below**

the dam. There is no apparent culvert under the next roadway and the area immediately below the roadway is upland with no apparent channel. There is no apparent channel for the next (approximate) 1/2- mile. It is unknown whether the channel between this point and the next impoundment exhibits an OHW. It is unknown whether the channel exiting the impoundment exhibits an OHW. It is fairly certain that a channel coming from the south contributes much more water to the downstream channel than the dammed channel. The stream is impounded again about 1/2 - mile downstream. There is clearly an outlet from this dam, however, it appears that water does not flow out of the dam at a reasonable frequency to support an OHW downstream. Therefore, due to the fact that three impoundments have been constructed within the first 1 1/2 miles below the wetland and it appears there are significant breaks in the OHW of the stream channel, this wetland does not exhibit sufficient proximity and connectivity to jurisdictional other waters; therefore, a nonspeculative ecological connection could not be made that would constitute adjacency.

Since the basin wetland is isolated, this stream channel is considered a non-jurisdictional conveyance with no connection to a surface water tributary.

Additionally, the wetland 1) is not used by interstate or foreign travelers for recreational or other purposes; 2) does not support fish or shellfish that could be taken and sold in interstate or foreign commerce; 3) is not used for industrial purposes by industries in interstate commerce.

Based upon these principle considerations, it is determined that the subject wetland is isolated and non-jurisdictional under the auspices of Section 404 of the Clean Water Act.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**
