MEMORANDUM FOR SEE DISTRIBUTION

SUBJECT: USACASCOM SCOE & FL Policy prohibiting use, possession, manufacture, purchase, or distribution of psychotropic substances.

1. References:

- c. DoD Directive 1010.4, Drug and Alcohol Abuse by DoD Personnel, 3 September 1997, with Change 1, 11 January 1999.

2. Applicability

- a. This policy applies to all Soldiers assigned to Fort Lee, Fort Eustis, and Fort Story, as well as, Department of Defense (DoD) Civilian Employees, and Non-Appropriated Fund (NAF) Employees temporarily or permanently assigned to United States Army Combined Arms Support Command and Fort Lee (USACASCOM, SCOE & FL), as well as Family members and unaffiliated civilians present on Fort Lee.
- b. Failure to obey this policy constitutes a violation of Article 92 of the Uniform Code of Military Justice and Soldiers who violate this policy may be subject to punitive action under the UCMJ and/or administrative action including loss of security clearance, demotion, and/or discharge from the United States Army. DoD and NAF Civilian Employees who violate this policy may be subject to administrative and disciplinary action. Any civilians, including dependants, who violate this policy may be removed from Fort Lee and denied re-entry.
- 3. Policy. This policy prohibits the use, possession, introduction, manufacture, purchase, and distribution of substances, and its respective paraphernalia, which produce a psychotropic "high" when ingested or inhaled. Such substances and paraphernalia include but are not limited to:
- a. Substances known commercially or colloquially as Spice (e.g., Spice 99, Spice Gold, Spice Silver, PEP Spice, Fire n' Ice, Geni, and Zohai).

- b. Salvia Divinorum and Silvinorin A, or any herbal blend in any form, to include those in alleged nutritional substances (e.g., Maria Pastora, Sage of the Seers, Diviner's Sage, Sally-D, or Magic Mint).
 - c. Mitrayna Speciosa Korth (e.g., Kratom, Thang, Kakuam, Ketum, or Biak).
 - d. Blue Lotus (e.g., Blue Water Lily, Egyptian Lotus, or Sacred Narcotic Lily of the Nile).
 - e. Concolculaceae Argyreia Nervoaa (e.g., Hawaiian Baby Woodrose).
 - f. Amanitas Mushrooms.
- g. Datura (e.g., Jimson Weed, Devil's Apple, Thorn Apple, Stinkweed, Moonflower, Malpitte, or Toloache).
 - h. Absinthe (containing Thujone).
- i. Substances Known as K2 or any synthetic form of Tetrahydrocannabinol (THC), Chemical JWH-018, or any form to include "K2 Blonde," "K2 Summit," and "K2 Citron."
 - Maui Hybrid or Hawaiian Haze.
- k. JWH-073 or JWH-018.
- l. 5-Meo-DMT (5-methoxy—N, N-dimethyltryptamine) (e.g., Powder Mushrooms, AMT [alphamethyltriptamine,], Bromo, or DMT [N, N-dimethyltriptamine]).
 - m. Lysergic Acide Amide (e.g., Morning Glory).
 - n. Dietary substances that are banned by the United States Food and Drug Administration.
 - o. Products made from or containing hemp oil.
- p. Paraphernalia includes any equipment, product, or material of any kind which is primarily intended or designed for use in manufacturing, compounding, converting, concealing, producing, processing, preparing, injecting, ingesting, inhaling, or otherwise introducing into the human body a substance intended to produce a psychotropic "high."
- (1) In determining whether an item constitutes drug paraphernalia, in addition to all other logically relevant factors, the following may be considered:
 - (a) instructions, oral or written, provided with the item concerning its use;
 - (b) descriptive materials accompanying the item which explain or depict its use;

- (c) national and local advertising concerning its use;
- (d) the existence and scope of legitimate uses of the item in the community.
