- Wildfires in Colorado: Contact has been made with the Colorado State agencies and FNS has received no requests for assistance at this time. FNS is coordinating with State officials on USDA Food needs. Over 32,000 people are evacuated with many more evacuations expected. FNS will continue close contact with the State agencies affected by the fires and will provide technical assistance as needed regarding disaster food response.
- Florida Flooding: FNS has received no requests for disaster nutrition assistance at this time. Replacements benefits are being made available on an individual basis to ongoing Supplemental Nutrition Assistance Program (SNAP) households that lost food purchased with their benefits. FNS will continue close contact with the State agencies affected by the flooding as damage assessments are completed and will provide technical assistance as needed regarding disaster food response.

Disaster SNAP Evaluation in Connecticut: Personnel from FNS Northeast Regional Office (NERO) Supplemental Nutrition Assistance Program (SNAP) completed a Disaster SNAP Management Evaluation in Hartford, Connecticut. Central Office managers and local staff from the New Haven and Hartford offices shared their disaster response experience with the reviewers. NERO completed a sampling of 32 Connecticut post disaster review cases. A report with observations and recommendations will be released soon.
