ACTIVATION

Hurricane Sandy and Nor'easter Storm, October 27, 2012 – November 19, 2012 – Emergency Support Function (ESF) 11 was activated at the Regional Response Coordination Centers (RRCC) in FEMA Regions III, II, I, and at the National Response Coordination Center (NRCC) in Washington, DC to assist the Federal Emergency Management Agency (FEMA) and States in addressing agricultural and natural resources needs associated with Hurricane Sandy and the subsequent Nor'easter. At the request of FEMA, ESF-11 deployed personnel to the State Emergency Operation Center (SEOC) in Boston, Massachusetts to develop debris management guidance and the SEOC in Albany, New York to provide guidance on USDA Food Nutrition Services (FNS) Programs, and the Joint Field Office in Queens, New York to provide assistance to the state's ESF-11 staff to address agriculture concerns.
