This contract is to provide Transportation Planning Program Support in the preparation of transportation studies and software revisions. EFLHD procured Pavement Management System (PMS) software (Contract DTFH71-04-C-00019 awarded 12/19/2003) to manage the road system of the National Park Service in their Park Roads and Parkway (PRP) program. Other Federal Land Management Agencies (FLMA) such as the US Forest Service, Fish and Wildlife Service, Bureau of Land Management within the United States also have road systems and require PMS support. This software is a customized version of Stantec Consulting's proprietary software, Highway Pavement Management Application (HPMA). HPMA uses pavement condition data (collected by the EFLHD Roadway Inventory Program), through a comprehensive set of analysis models, to determine current and future road and network condition; define a set of Maintenance and Rehabilitation (M&R) needs of the network' prioritize and budget for the M&R treatments and development of the M&R program of projects.
