REPORT OF THE AUDIT DIVISION ON THE EVELIO S. ESTRELLA CAMPAIGN COMMITTEE •

# I. Background

# A. <u>Overview</u>

This report is based on an audit of the Evelio S. Estrella Campaign Committee ("the Committee"), undertaken by the Audit Division of the Federal Election Commission in accordance with the Commission's audit policy to determine whether there has been compliance with the provisions of the Federal Election Campaign Act of 1971, as amended ("the Act"). The audit was conducted pursuant to Section 438(a)(8) of Title 2 of the United States Code which directs the Commission to make from time to time audits and field investigations with respect to reports and statements filed under the provisions of the Act.

The Committee registered with the Federal Election Commission on August 25, 1976 in support of Mr. Evelio S. Estrella, candidate for the office of U. S. Representative from the 14th Congressional District of Florida. The Candidate designated the Committee as principal campaign committee on August 25, 1976. The Committee maintained its headquarters in Miami, Florida.

The audit covered the period from July 15, 1976 through December 2, 1976 the final coverage date of the termination report filed by the Committee. The Committee reported a beginning cash balance of \$-0-, total receipts for the period of \$15,785.00, total expenditures for the period of \$15,785.00 and a closing cash balance of \$-0-.

This audit report is based on documents and working papers which support each of the factual statements. They form part of the record upon which the Commission based its decisions on the matters in the report and were available to Commissioners and appropriate staff for review.

# C. Scope

The audit included such tests as verification of total reported receipts and expenditures and individual transactions; review of required supporting documentation; analysis of Committee debts and obligations; and such other audit procedures as deemed necessary under the circumstances.

It is the opinion of the Audit staff, based upon examination of the reports and statements filed and the records presented, that the reports and statements of the Evelio S. Estrella Campaign Committee fairly present the financial activities of the Committee for the period covered by the audit.
