REPORT OF THE AUDIT DIVISION ON THE FEDERAL CAMPAIGN COMMITTEE OF NEVADA

I. Background

A. Overview

This report is based on an audit of the Federal Campaign Committee of Nevada ("the Committee"), undertaken by the Audit Division of the Federal Election Commission in accordance with the Commission's audit policy to determine whether there has been compliance with the provisions of the Federal Election Campaign Act of 1971, as amended ("the Act"). The audit was conducted pursuant to Section 432(a)(8) of Title 2, of the United States Code which directs the Commission to make from time to time audits and field investigations with respect to reports and statements filed under the provisions of the Act.

The Federal Campaign Committee of Nevada registered with the Federal Election Commission on April 13, 1976 as a Federal campaign committee representing the Republican Party in the State of Nevada. The Committee maintains its headquarters in Reno, Nevada.

The audit covered the period April 1, 1976, the beginning coverage date of the initial report filed, through March 31, 1978, the final coverage date of the latest report filed at the time of the audit. The Committee reported a beginning cash balance at July 1, 1976 of \$-0-, total receipts for the period of \$4,000.00, total expenditures for the period of \$3,989.00, and a closing cash balance at December 31, 1977 of \$11.00. ^{1/}

This report is based on documents and working papers supporting each of its factual statements. They form part of the record upon which the Commission based its decision on the matters in the report and were available to Commissioners and appropriate staff for review.

B. Key Personnel

The principal officers of the Committee during the period covered by the audit were Edwina Prior, Chairperson, and Lucie Humphrey, Treasurer.

C. Scope

The audit included such tests as verification of reported receipts and expenditures and individual transactions; review of required supporting documentation and analysis of Committee debts and obligations; and such other audit procedures as deemed necessary under the circumstances.

II. Auditor's Statement

It is the opinion of the Audit staff, based upon examination of the reports and statements filed and the records presented, that, the reports and statements of the Federal Campaign Committee of Nevada fairly present the financial activities of the Committee for the period covered by the audit. No material problems in complying with the Federal Election Campaign Act were discovered during the course of the audit.
