- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **This artificial wetland is located on the Grand Forks Air Force Base created as a result of adjacent development of driveways and the building pad for Building 542. The basin functions as a storm water detention facility and is connected to the underground storm sewer system by a series of culverts, a paved channel, and street gutter flow. It is not used by interstate or foreign travelers for recreational or other purposes; does not support fish or shellfish that could be taken and sold in interstate or foreign commerce, and is not used for industrial purposes by industries in interstate commerce. Based upon these principle considerations, it is determined that the subject wetland is non-jurisdictional under the purview of Section 404 of the Clean Water Act .**
