Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The JD is for an isolated wetland that flows into a closed wetland basin complex. The wetland is approximately 0.3 acre in size and lacks a discernable surface outlet to any waters of the United States (WOUS). The receiving closed basin has caused the road to become inundated as water drains in and has no means of flowing out. This constitutes hydrologic surface isolation. Further, it is determined that the wetland lacks sufficient proximity to WOUS and documentation to support an ecological relationship that would constitute "adjacency".

<u>Lastly</u>, it is determined that the wetlands: 1) are not used by interstate or foreign travelers for recreational or other purposes; 2) do not support fish or shellfish that could be taken and sold in interstate or foreign commerce; and 3) are not used for industrial purposes by industries in interstate commerce.

Based upon these principle considerations, it is determined that the subject waters are *isolated and nonjurisdictional* under the auspices of Section 404 of the Clean Water Act.
