Explain: The JD review area contains 7 isolated depressional pothole wetlands. (See Attached Wetland Table and Maps) The wetlands are located within

entirely closed drainage basins with no discernable surface outlet, other than some that have drains to other isolated basins. Further, these wetlands: 1) are not used by

interstate or foreign travelers for recreational or other purposes; 2) do not support fish or shellfish that could be taken and sold in interstate or foreign commerce; and 3) are not used for industrial purposes by industries in interstate commerce. Based upon these principle considerations, it is determined that the subject wetlands are
