Explain: The JD review area contains 50 isolated depressional pothole wetlands. The wetlands are located within an entirely closed drainage basin with no discernable surface outlet. Further, these wetlands: 1) are not used by interstate or foreign travelers for recreational or other purposes; 2) do not support fish or shellfish that could be taken and sold in interstate or foreign commerce; and 3) are not used for industrial purposes by industries in
