2. Non-regulated waters/wetlands (check if applicable):³

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The JD is for twelve (12) isolated depressional wetlands ranging from approximately 0.01 to 0.2 acres in size. All of these waters are located within the Drift Plains region of North Dakota, and consist of pothole and small farmed depressional wetland features. USGS Topographic maps indicate the presence of closed basins and slight upland swales. NRCS official wetland map indicates the presence of farmed wetlands. Based upon the best available information, these 12 wetlands are confined 100% by uplands and would constitute an "adjacent to adjacent" hydrologic and physical proximity to other potential waters of the United States. For these reasons, the wetlands do not exhibit any discernable surface connectivity or interaction with jurisdictional waters of the U.S.. It is also determined that these waters: 1) are not used by interstate or foreign travelers for recreational or other purposes; 2) do not support fish or shellfish that could be taken and sold in interstate or foreign commerce; and 3) are not used for industrial purposes by industries in interstate commerce. Lastly, the waters do not exhibit sufficient proximity and/or connectivity to jurisdictional other waters; whereby, nonspeculative ecological connection(s) could be made that would constitute adjacency.

Based upon these principle considerations, it is determined that the subject waters are *isolated and nonjurisdictional* under the auspices of Section 404 of the Clean Water Act.
