Explain: The JD review area contains three (3) isolated depressional pothole wetlands. These wetlands are located within an entirely closed drainage basin with no discernible surface outlet. Further, these wetlands: 1) are not used by interstate or foreign travelers for recreational or other purposes; 2) do not support fish or shellfish that could be taken and sold in interstate or foreign commerce; and 3) are not used for industrial purposes by industries in interstate commerce. Based upon these principle considerations, it is determined that the subject wetlands are

isolated and nonjurisdictional under the auspices of Section 404 of the Clean Water Act
