Explain: This JD review area contains a glacial lake approximately 515 acres in size and its fringe wetlands. The basin is isolated, intrastate and non-navigable (no boat ramp). No evidence could be found indicating the area is utilized for recreational or industrial purposes. The Lake is located over 10 miles from Green Lake, which is the closest TNW. Although there are several isolated lakes, potholes and intermittent drainages nearby, there is currently no hydrological connection between the Lake and any "known to be" jurisdictional waterways.
