Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The JD is for an isolated depressional wetland (#55) with no discernable connection to any waters of the US. The wetland is 0.19 acre in size and consists of a shallow, closed basin that does not exhibit any hydrologic interaction with other waters or potential waters of the US. This constitutes an "isolated" determination.

It is further determined that the wetland: 1) is not used by interstate or foreign travelers for recreational or other purposes; 2) does not support fish or shellfish that could be taken and sold in interstate or foreign commerce; and 3) is not used for industrial purposes by industries in interstate commerce.

Lastly, the wetland does not exhibit sufficient proximity and/or connectivity to jurisdictional other waters; whereby, nonspeculative ecological connection(s) could be made that would constitute adjacency.
