Explain: **The JD review area contains one (1) isolated depressional pothole wetland. The wetland is located within an entirely closed drainage basin with no discernible surface outlet. Further, this wetland: 1) is not used by interstate or foreign travelers for recreational or other purposes; 2) does not support fish or shellfish that could be taken and sold in interstate or foreign commerce; and 3) is not used for industrial purposes by industries in interstate commerce. Based upon these principle considerations, it is determined that the subject wetlands are isolated and nonjurisdictional under the auspices of Section 404 of the Clean Water Act**
