Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: The jd review contains two (2) isolated depressional artificial wetlands located in a road ditch. These wetlands do not outlet and were likely created as a result of poor drainage and ponding is able to occur. Further, these wetlands are not used by interstate or foreign travelers for recreational or other purposes; do not support fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not used for industrial purposes by industries in interstate commerce. Based upon these considerations, it is determined that the subject wetlands are isolated and non-jurisdictional under the purview of the Section 404 of the Clean Water Act. .
