- Next ITC board meeting will be at the Ka Nee Tah Resort in Warm Springs, Oregon on September 13-15.
- IFMAT-III Info:
  - The oversight team will be having a call to finalize the Team and activities.
  - Received funding for \$300,000 from the USDA Forest Service in addition to the original funding source.
  - FS is interested in using ITC to contract study similar to the IFMAT study for Region 6.
- Working on the symposium proceedings CD and synthesizing the findings/ recommendations from ITC Symposium workshops.

#### Jim Erickson

- Tribal Forest Protection Act getting money from FS and looking for tribal interest/ participation. Will be doing a Survey Monkey to know there is an opportunity for stewardship work. Key interest groups will be identified and site visits will take place for the project.

• New FireCodes have been loaded. Made request that F8-F9 be loaded, which will take us to end of FY11.

#### Dave Koch, Associate Director, Training

- The USDA FS efforts to begin using the GS-301 Job Series were submitted to OPM and USDA for review and approval. OPM and USDA leadership questioned the degree to which DOI Bureaus were engaged in the decision to use the GS-301 series.
- Record Keeping for Firefighters IQCS is our system of record for firefighters, but the Blue and Redbooks say firefighters will be responsible for maintaining hard copies. Here are four questions to consider for the 2012 Blue Book:
  - 1. Should we <u>not</u> maintain folders for employees and utilize IQCS as intended? IQCS, as the official system of record, is technically all anyone needs to validate a responder's qualification status and history. By keeping hard copy files we are creating extra unnecessary work and, creating something that investigators can potentially shoot holes in if everything is not in order.
  - 2. Should we only maintain folders for regular employees (tribal and GS) and use IQCS for everyone else? If it is still desired to maintain hard copy records, should we consider limiting only to tribal and GS employees, thereby minimizing considerable paperwork?

- 3. Should we go electronic for all employee files? Scanning and saving records will free up considerable file space.
- 4. Should we include verbiage in the Blue Book that state's employees are "ultimately responsible for managing their records and should not rely on the government to do this for them."
  - Suggestion to have Greg Peterson respond to this through the Operations Committee.
- The deadline to have the required IS-700/800 NIMS Training has been pushed back to September, 2012 in the 301-1.

## Joel Kerly, Aviation Manager

- P3s were terminated from the USDA FS contract. To augment airtankers availability, NIFC has pulled 2 Convair 580's from Canada, and have ability to request 6 additional aircraft if needed.
- Reminder as we get close to end of FY managers need to have an AMS username and password to do the reconciliations. Contact Joel if you have questions.

IT, Fire Personal, HR specialists and DC representatives are engaged to develop guidelines on who will be required to use these cards while on fire assignments. The team will provide their feedback to the DOI Bureaus for implementation.

- Mary Taber will be in Fort Apache to do a Fuels Effectiveness after action review, who then work with the Lessons Learned Center to share the results of effective fuels treatments.
