Hood National Forest when a boulder rolled over him while resting in a ravine that provided shelter from the wind. He was airlifted to Emanuel Hospital in Portland, Oregon and was released home September 11. A Facilitated Learning Analysis Team conducted a review to provide lessons learned from the incident and to improve future performance. The Wildland Fire Foundation provided \$500.00 to assist the family while they were staying near the hospital.

- GPRA October 8th Fire occurrence data will be pulled for FY2010. Steve Larrabee will send out a report card showing the status of fire reporting by Unit for FY2010 and email to each Regional FMO. This will probably occur on 9/15.
- WFMI Has a new auto-reset feature for passwords. It is critical WFMI users have their current email listed for their WFMI profile. When you request an auto reset for a password, the system will send an email to your listed email in WFMI. You have to click on the link within the email to validate your email address. Once validated, a new temporary password will be sent to you. Caution there has been email problems between BIA and BLM for the past couple months. This is an intermittent problem. If an email is not received when using the auto-reset feature, call the WFMI Help Desk at 208-387-5734.
- FPA FY11 guidance should be issued soon. An Analysis Working Team is being formed to do the analysis for FPUs this year. This will continue until FPA is fixed and produces viable outputs. The field will re-engage with this process once stable.

- BIA-NIFC website usability testing is complete. Indian Affairs Web Developers have suggested a
 new web taxonomy based upon the input of the user audience. Once the site structure is
 complete, will begin developing and populating WebPages.
- The Indian Affairs Web Council is working to develop a position description (PD) for Web Content Managers (WCM). The council will approve the PD Oct. 6.
 - Currently, WCMs are taking on web responsibilities as a collateral duty. OCIO intends to
 institutionalize and define the role WCM play in developing the Indian Affairs web
 presence. Currently, any WebPages hosted under bia.gov must have a content manager.
 OCIO expects WCMS to participate on the IA Web Council and perform training to new
 content managers to help grow the organization.
- "Apache 8 The Movie" is a film documentary that tells the story of four White Mountain Apache woman firefighters that have worked on the Apache 8 hand crew over the past 22 years.  Operation Alliance.
