Appendix L. Dependency and Indemnity Compensation Rates

NOTE 2: The Dependency and Indemnity Compensation (DIC) rate remained unchanged from December 1, 2008 through November 30, 2011.

*NOTE 3: DIC is payable at a flat rate and increased by cost-of-living adjustments when a veteran dies on or after January 1, 1993. An additional amount may be payable if the veteran was receiving a Serviceconnected disability compensation (or would have but for the receipt of retired or retainer pay) for at least 8 years immediately preceding death. If a veteran died before January 1, 1993, then DIC was payable based on the pay grade of the veteran. Effective January 1, 1993, DIC was payable at the flat rate of \$750 (including \$165, if applicable according to <u>*Title 38, United States Code, section 1311(a)(2)*</u>) if it is more favorable than the DIC amount based on the veteran's pay grade. The following table provides the historical flat rates (including additional amount, if applicable) through current.
