



Freight Management And Operations

The National Highway Institute (NHI) now offers a Certificate of Accomplishment in Freight Management and Operations. NHI offers Certificates of Accomplishment to recognize individuals who have successfully completed and achieved passing grades in four freight related NHI trainings. The certificate program features suites of complementary NHI trainings bundled together to enable participants to enhance their depth and breadth of knowledge and expertise in the area of freight transportation.

COURSE SUITE: The Certificate of Accomplishment in Freight Management and Operations features the following four NHI courses:

- FHWA-NHI-139002—Uses of Multimodal Freight Forecasting in Transportation Planning
- FHWA-NHI-139003—Advanced Freight Planning*
- FHWA-NHI-139005—Linking Freight to Planning and the Environment
- FHWA-NHI-139006—Integrating Freight in the Transportation Planning Process WBT

* Participants must successfully complete either FHWA-NHI-139001 (prior to 31 March 2008) or FHWA-NHI-139006 (after 1 April 2008) Integrating Freight in the Transportation Planning Process prior to attending 139003. Participants **MUST** bring a copy of their certificate of completion to their scheduled session of FHWA-NHI-139003 and provide it to the lead instructor.

BENEFITS: The Certificate of Accomplishment in Freight Management and Operations offers participants the following benefits:

- Enhanced breadth and depth of knowledge in freight transportation area
- Well-versed in the issues and execution of freight management and operations programs
- Recognition of completion of core courses offered in the Freight Management and Operations area
- Demonstrated personal commitment to self-improvement and transition to higher level positions
- Gained knowledge and expertise to apply higher level skills in real world applications

TARGET AUDIENCE: Mid- and high-level transportation planners and freight transportation planners from state DOTs, MPOs, local governments and Federal agencies; consultants, private sector freight managers, economic development analysts.

REQUIREMENTS: Successful completion and passing grades in four designated Freight Management and Operations courses since January 1, 2004, are eligible for inclusion in the Certificate of Accomplishment. Sessions attended prior to that date are not eligible. No waivers or substitutions will be accepted. All the courses in the suite must be completed within four years of taking the first course. To be eligible to receive a Certificate of Accomplishment, participants must complete and pass the end of course test for each training in the suite. After successfully completing all the trainings in the suite, please contact the NHI Registrar at nhiregistrar@dot.gov to request your Certificate of Accomplishment.
