C. PROJECT LOCATION AND BACKGROUND INFORMATION: The review area is approximately 700 acres in size and is located in the lower reaches of the Six-Mile Creek Watershed in Brookings County, SD. Six-Mile Creek flows through the review area and continues approximately 2.8 river miles before it enters the Big Sioux River, which is a Traditional Navigable Water. Thirteen wetlands were identified within the review area as well four interconnected sanitary sewer ponds. The review area has been subject to extensive disturbance. The Six-Mile Creek channel running through the review area has been previously straightened and channelized. In addition wetlands within the review area appear to have been impacted by previous agricultural activity, road construction, and site grading associated with the construction of an airport.

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Five wetlands (Wetland C,D,E,J, and K) reviewed in this AJD were determined to be isolated with no known surface water connection to Six-Mile Creek. Four sanitary sewer ponds were identified in the review and were determined to be isolated. All aquatic resources determined to be isolated were found to lack a surface water connection to Six-Mile Creek. Aerial photography and wetland delineation data were primarily used to determine if a surface water connection was present between these wetlands and Six-Mile Creek. A dotted blue line was observed on the USGS quadrangle map (Brookings – SD) that appeared to connect Wetland J to Six-Mile Creek. Further review of aerial photography suggested that this channel is no longer present on the landscape and was likely eliminated during earlier episodes of site grading that appear to have occurred within the review area.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
