In recent years, changes and improvements to the city storm water system and transportation infrastructure in association with urban expansion/development (added to the ground water input from a historical high water table) have significantly increased hydrology to the waterway.*

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Mocasin Creek flows to the James River (TNW). The unnamed tributary consisting of a network of interconnected wetlands and urban drainage channels/ditches (including enclosed storm drains in the City street system) that carry perennial flows beginning with ground water flows and supplemented with spring snow melt and subsequent precipitation events that fill the abutting wetlands and produce pulse flows. With the relatively flat gradient of the slope wetlands in the upper reach, the Spring pulse gradually meters the flows downstream. The wetland delineation completed for the site identifies the waterway as a system of "wetland complexes" throughout its course on the property.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: The delineated Wetland Complex system is located in the upper reach of a larger wetland/urban drainage complex consisting of natural bed and bank channel and engineered storm drainage channels carrying runoff to the Mocassin Creek RPW and James River TNW. The contiguous wetland complex system supports obligate, facultative-wet, and other wetland plant species and contains hydric soils typical of saturated soil and ponded water conditions.
