Blue Blanket Lakebed was previously determined to be a non-jurisdictional wetland due to SWANCC, May 1, 2006 under Corps ID#: NWO-2006-20085. The ephemeral tributary flows to Blue Blanket Lakebed which is located within an entirely closed drainage basin with no discernable surface outlet. The wetland is not located within a reasonabley close proximity to other jurisdictional waters; whereby nonspeculative ecological connection(s) could be made. Further, this wetland: 1) is not used by interstate or foreign travelers for recreational or other purposes; 2) does not support fish or shellfish that could be taken and sold in interstate or foreign commerce; and 3) is not used for industrial purposes by industries in interstate commerce. Based upon these principle considerations, it is determined that the subject wetland is nonjurisdictional under Section 404 of the Clean Water Act
