- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The JD review area contains a dam and 0.70 acre reservoir in an unnamed, ephemeral waterway. The overflow from the dam and reservoir enters the City's storm water sewer system. The sewer system provides a non-jurisdictional conveyance for the water to eventually reach Dog Ear Creek. The waterway is not located within a reasonably close proximity to jurisdictional other waters; whereby, nonspeculative ecological connection(s) could be made. Further, this waterway: 1) is not used by interstate or foreign travelers for recreational or other purposes; 2) does not support fish or shellfish that could be taken and sold in interstate or foreign commerce; and 3) is not used for industrial purposes by industries in interstate commerce.**

Based upon these principle considerations, it is determined that the ephemeral waterway and reservoir are nonjurisdictional under the auspices of Section 404 of the Clean Water Act.
