#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Provide rationale indicating that wetland is directly abutting an RPW: The wetland delineation completed for the project site identifies east and west wetlands (east and west of a breached dam on Artichoke Creek) totaling 4.8 acres. The east wetlands (2.6 acres) were largely created by the dam construction. The west wetlands (2.2 acres) are natural fringe wetlands including artificially created areas from past farming/ranching activites at the site. The Artichoke Creek tributary system has historically drained agricultural land from approximately west central Potter County to SW Potter and NW Sully Counties where it enters Lake Oahe. From the review area, the tributary reach to Lake Oahe is less than 10 stream miles. The abutting wetlands are palutrine, seasonally flooded (slope wetlands) interconnected to Artichoke Creek. The tributary carries perennial flows from snow melt and precipitation events during most years, with the exception of extreme drought conditions . With the relatively flat gradient of the stream, pulse flows gradually meter runoff downstream. Ground water is also a likely contributing sources of hydrology to the stream. In addition, increasing agricultural drainage contrubutes a significant source of runoff to the stream.
