- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Four wetlands were reviewed in this JD that were determined to be Isolated with no known surface water connection to the South Fork of the Whetstone River or any of its tributaries (See Table 1 attached). A review of recent aerial photography suggests that the wetlands in this JD are located in isolated depressions that lack confined outlets or channels draining into any jurisdictional waters. Similarly a review of USGS quadrangles suggests that no channels are present that would create a surface water connection between any of the wetlands reviewed in this JD and any jurisdictional waters.**

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland boundaries used in this JD are based on National Wetland Inventory data. The applicant requesting this JD verified the presence of all wetlands using the Corps 1987 wetland manual; however, the complete wetland boundary was not delineated during the site investigation. In Section IV (A) of this JD the South Dakota Corps Regulatory Offices indicates that they do not concur with the delineation report. The non-concurrence box was checked in this section to reflect that the delineation did not define the precise boundary of the delineated wetlands. The Corps does concur that the wetlands included in this JD meet the criteria of the 87 Wetland Manual.
