



**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This wetland is completely surrounded by upland with little evidence of any "continuous surface connection" to other potentially jurisidictional waters. This wetland is simply a depression, with the only sources of water likely being precipitation, local runoff, and seepage from a nearby well. In addition, access to the wetland is restricted, essentially

eliminating the potential for the wetland to (1) be used by interstate or foreign travelers for recreational puposes, (2) produce fish or shellfish which are or could be taken and sold in interstate or foreign commerce or (3) be used for industrial purposes by industries in interstate commerce.


