Forest Facts and Accomplishments:

Program Highlights:

Cooperative Fire Protection

The state assisted with three Community Wildfire Protection Plans. Hazardous fuels were treated on 450 acres using prescribed fire or equipment. The state trained 640 firefighters, delivered 75 prevention programs, and provided 93 volunteer fire departments with grants for equipment and training. Fire departments received \$19,300 in fire equipment under the Federal Excess Personal Property Program and \$2.4 million from the DoD Fire Fighter Property Program.

Forest Health Protection

A foreign insect, hemlock woolly adelgid, found earlier in Cumberland County, is still a major concern. The Maine Forest Service is monitoring populations of spruce budworm, which were found in traps in higher numbers in 2011. Disease surveys for hemlock tip blight

detected more widespread and severe damage, while a higher incidence and severity of needle casts was also observed, especially in white pine. Surveys revealed Cedar leaf blight on northern white cedar in Cumberland and York Counties. Monitoring continued for the invasive Asian longhorned beetle, emerald ash borer, Sirex wood wasp, and brown spruce longhorned beetle with no positive detections.

Forest Legacy

Maine protected 7,910 acres, adding to working forests already protected across large expanses of land. The project protects key snowmobile trails, guarantees hunting opportunities, and protects views from Maine's iconic Mount Katahdin, the northern terminus of the Appalachian National Scenic Trail.

Landowner Assistance

The state has several "landscape-based" projects using funds from "redesign" grants. The Kennebec Woodland Partnership, launched in 2009 to promote stewardship and conservation, now has a dozen member organizations. The Presumpscot Watershed Project, which includes the drinking water source for Portland, the state's largest city, is a priority. To encourage forest land retention, the state is providing Stewardship Plans for private woodland owners, land trusts, and municipalities. The Project also provides incentives to construct and use portable bridges during logging to protect water quality.

Urban and Community Forestry

Project Canopy worked with state and regional partners to deliver training to 654 adult program participants. The Maine Forest Service staff has strong partnerships with state agencies such as the Maine Department of Transportation (MDOT) and the Maine Department of Agriculture. Project Canopy staff worked with MDOT to design and implement a new workshop series for local road officials dealing with tree issues. Six workshops were held throughout Maine, attended by road commissioners, tree wardens, city arborists, and public works crews.

Wood Education and Resource Center (WERC)

The Maine Indian Basketmakers Alliance received a grant to expand the market for wooden baskets and to improve the marketing and economic competitiveness of Native American basketmakers. A wood energy feasibility study was completed for Nestle Waters in Poland Springs, ME. The Maine Forest Service and the Northeastern Area are cooperating on an ARRA project that has funded 22 projects now underway.
