particle sorting and deposition, vegetation matting and removal, and wrack lines indicating a large flow after major rain events in the upper reaches of the watershed. Downstream of the H1 Freeway, however, the Gulch quickly loses these characteristics as the Gulch channel becomes shallower and heavily vegetated until finally disappearing on the plain before reaching the TNW (Pacific Ocean) Due to the engineering of storm water detention/retention systems along the length of the Gulch, including use of any regular or remaining hydrology as golf course obstacles/water holes, there is no physical evidence of any tributary flow to the Pacific Ocean from the upstream portions of the Gulch. The last trace of the Gulch is found just over one-mile from the shoreline of the Pacific Ocean. Based on these findings, I have determined that the Kaloi Gulch is an isolated water not under Corps jurisdiction.

#### C. SIGNIFICANT NEXUS DETERMINATION
