The topography is comprised mostly of pahoehoe lava flows

dating back to the eruption of Mauna Loa in 1855. There is very little in the way of soil formation on these flows; however, this area receives rainfall in excess of 125" per year, keeping nearly every pocket in the topography filled with water. There are an estimated 12,000 individual wetlands in pockets on this recent flow or its substrate which have soils high in organic matter due to decomposing vegetation. These wetlands range in size from .25 to 2.0 meters in diameter and have no connection to the surface tributary system of the island. There is no discernable flow between the wetlands and/or towards the lower elevations, although there may be flow down to the groundwater system through cracks or seams in the lava flows. There are no nearby intermittent or permanent streams to which a hydrologic connection could be made. The wetlands have no known commercial use as no commercial uses are present or allowed in this State-woned Conservation District land. The wetlands do not contribute to the chemical, physical, and/or biological integrity of any TNW. As such, the wetlands are considered isolated, with no significant nexus to a TNW. The wetlands on the project site are not within USACE jurisdiction.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
