Summarize overall biological, chemical and physical functions being performed: There is only one wetland complex in this watershed, of which the subject wetland is a part of and on the extreme upstream edge. The entire area is within 10 msl and runoff from the town of Haleiwa flows into the wetland before going into the Paukauila stream and out into the TNW. The wetlands function to filter out pollutants from the residential/commercial urban environments, such as herbicides, pesticides, fertilizers and oil and gas overflows. All of these are potentially harmful to the aquatic marine environment.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
