### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

**Note: the above list of considerations is not inclusive and other functions observed or known to occur should be documented below:**

1. **Significant nexus findings for non-RPW that has no adjacent wetlands and flows directly or indirectly into TNWs.** Explain findings of presence or absence of significant nexus below, based on the tributary itself, then go to Section III.D: The tributary (Hapuna Stream) has the capacity to carry a significant amount of sediment in floodwaters directly into the TNW (Pacific Ocean) as it breaks through the Hapuna sand bar during times of heavy rains (severe cases of such flooding documented in 1996, 2000, and 2004). Most of the watershed is arid, highly erodible, and barren of vegetation, thereby making the watershed ideal for losing sediment due a lack of soil stabilization expected with vegetation. Due to the ephemeral nature of the stream, it is unlikely to support any aquatic organisms through to the completion of their life-cycles, nor does it provide much in the way of sustainable habitat for waterbird species in the area. However, Hapuna Stream does have the capability to transfer nutrients during flow times, and organic carbon that could support downstream food webs. North, along the coast are coral reefs that flourish along the rocky shore. The current off the coast heads north and west, aided by windswell. Flash flooding along this route poses the potential to distribute stream sediment across, and negatively impacting, these coral reef habitats (special aquatic sites). During flood events, and times of the year when Hapuna beach is most narrow, there is a risk that Hapuna Stream carries a large sediment load directly into the ocean, which directly impacts the chemical, physical, and biological integrity of the TNW. Therefore, a significant nexus is present.
