### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

1. **Significant nexus findings for non-RPW that has no adjacent wetlands and flows directly or indirectly into TNWs.** Explain findings of presence or absence of significant nexus below, based on the tributary itself, then go to Section III.D: The Kihei region is prone to flooding as many of the previously existing natural gulches and associated wetlands have been altered, diverted and/or developed over, interrupting flow conveyance to the ocean. Kulanihakoī Gulch is generally dry, but conveys large volumes of flow during annual seasonal rain and year round during heavy flow events. Pictures of the area identify a well-defined bed and bank with a wide stream bed, indicating potential to convey heavy flow from the mountains to nearshore wetlands, and eventually to the Pacific Ocean. The arid, unvegetated regions upstream at the foothills of the mountains in this watershed provide heavy sediment loads which are conveyed to the ocean by the dry gulches of this area. Wetlands near the ocean filter out some of the sediment and turbidity; however, remnant pollutants and organic sediments flow through the Gulch to off shore coral reef habitats, considered special aquatic sites, thereby affecting the chemical, physical and biological integrity of the TNW. As such, this Gulch has a significant nexus to the Pacific Ocean.
