### **BRIGADIER GENERAL JOHN L. DOLAN**

Brigadier General John L. Dolan is the Commander,451st Air Expeditionary Wing and Kandahar Airfield (NATO), Kandahar, Afghanistan. He commands a composite wing that includes air mobility; aero-medical evacuations; close air support; combat search and rescue; intelligence, surveillance and reconnaissance; and electronic attack assets in support of the International Security Assistance Force and Operation Enduring Freedom. He is also responsible to the Commander, ISAF, for the operational efficiency and readiness of Kandahar Airfield. General Dolan acts as Senior Airfield Authority and a task force commander-equivalent in defense of the airfield and the surrounding ground defense area, exercising centralized coordination of airfield operations, logistics, NATO assets, and real estate management while leading all force protection actions in defense of nearly 26,000 assigned and attached personnel.

General Dolan received his commission through the Air Force ROTC program at the University of Northern Colorado, in 1986. He has held various squadron, wing and headquarters level positions in multiple overseas assignments to include instructing and commanding the U.S. Air Force F-16 Weapons School. He deployed as Vice Commander, 332nd Air Expeditionary Wing, Joint Base Balad, Iraq and commander 8th Fighter Wing, Kunsan Air Base, Republic of



Korea. Additionally he served on the Joint Staff for warfighter requirements, Chief, Senate Legislative Liaison, and Deputy Director, Legislative Liaison, Office of the Secretary of the Air Force.

Brigadier General Dolan is a command pilot with more than 3700 flying hours, including More than 400 combat hours earned during Operations IRAQI FREEDOM and NORTHERN WATCH.
