Federal TBI Program

More than 3.17 million Americans live with a disability as a result of a traumatic brain injury (TBI). Many of these individuals and their families are confronted with inadequate or unavailable TBI services and supports. Passage of the Traumatic Brain Injury Act of 1996 (PL 104-166) signaled a national recognition of the need to improve state TBI service systems. The Act authorized the Health Resources and Services Administration to award grants to States for the purpose of planning and implementing needed health and related service systems changes.

Michigan's Grant History

From 1997-2011, Michigan has received \$1,868,335 in Federal TBI Planning, Implementation, Post-Demonstration, and Implementation Partnership Grants. The State has provided \$1,038,130 in matching support.

Grant Objectives

- Implement systems change to increase the State's capacity to provide access to comprehensive and coordinated services for individuals with TBI and their families.
- Increase state and local capacity to serve all individuals in Michigan, through partnerships with public and non-profit associations that will target key high-risk populations.
- 3. Enhance Michigan's TBI educational and outreach products and partner with State, local, and private entities to incorporate TBI content in ongoing training activities.
- 4. Monitor, assimilate, and disseminate data to ensure that Michigan policy makers, the TBI Council, Michigan citizens, and State and local agencies have needed information on the significance of TBI, as well as the risk factors,

service needs, and program effectiveness related to TBI.

Progress

- 1. The TBI Waiver application has been submitted and is under review.
- 2. Members from the TBI Services & Prevention Council recently presented at the Center for Injury Research and Policy at the CDC.
- Revised and updated Modules 1-4 of the TBI & Public Services online training. Two additional TBI online training modules (pediatric and older adult) have also been developed.
- 4. Abstracted data from the medical records/document reviews of FY07 to FY11 participants in the TBI-MOU for the TBI-MOU retrospective study; conducted preliminary analysis of the abstracted data for the TBI-MOU retrospective study, and prepared a draft report of the initial findings
- 5. The BIAMI Veterans Program Director presented as a panelist for the Military Officers Association of America and the Naval Institute's "Defense Forum Washington" Conference

Continuing Effort

Michigan continues to improve service coordination among several public and private agencies to ensure that TBI services and supports are adequate to meet the individual needs of our citizens.
