## 80 APS returns to Dobbins

Eighty-eight members of the 80th Aerial Port Squadron returned to Dobbins Air Reserve Base last month after nearly a year on active duty working in support of Operation Iraqi Freedom.

Happy families and friends patiently stood by as the reservists were officially welcomed home by Brig. Gen. Thomas Stogsdill, 94th Airlift Wing commander, Col. Steven Slick, 94th Mission Support Group commander, Lt. Col. John Fitter, 80th APS commander, and Chief Master Sgt. James West, 94th Airlift Wing command chief.

Lt. Col. Fitter thanked the squadron for a job well done and for their dedication to the mission in support of Operation Iraqi Freedom.

"I am extremely proud of every one of you and am glad to have you back home," Lt. Col. Fitter told the group. "You did an outstanding job. You went above and beyond and did more than what you were deployed to do. We are all so happy to have you back home with your families and are looking forward to integrating you back into the unit. Welcome home."

The deployment was the first for the 80th APS and it presented some challenges for the reservists and their families.

"Leaving my family was hard," said Staff Sgt. Ralph Cordy who left behind his wife and three sons. "My wife is a full-time nursing student and runs her own business. I felt guilty leaving her with three boys to handle but she understood."

Although he is a firefighter for Dekalb County, in the Air Force Reserve, Sergeant Cordy is a cargo specialist and regularly deals with exporting and importing supplies and equipment. However, while deployed, Sergeant Cordy worked primarily in passenger services handling troop movement for U.S. and Spanish service members heading to and from Iraq. "It was different but it was a good learning experience," he said.

According to Senior Master Sgt. Sandra Wright, 80th APS first sergeant, the squadron is made up of several entities including a joint inspection section; an air terminal section; an operation center; a passenger services section; a ramp section; a cargo section; a fleet services section; and load planning section. The mission of the squadron is to deploy trained personnel and serviceable equipment to provide aerial support of air-

land operations in high threat areas; operate c-air interface; augment aerial port of embarkation/aerial port of debarkation; and operate unit move, on-load and off-load locations.

Squadron members spent their deployment in several locations including Kuwait International Airport, Kuwait; Manas International Airport, Kyrgyzstan; Rhein Main Air Base, Germany; Pope Air Force Base, N.C.; Incirlik Air Base, Turkey; and Bagram Air Base, Afghanistan; and Dover Air Force Base, Del. before returning to Dobbins in staggered groups.

Sergeant Cordy drove from Dover AFB and headed straight for a football field in Henry County to see one of his sons play in a pony-league football championship game.

"My boys were totally surprised to see me," he said. "And, when I got home the house was decorated. It was nice."

The 80th APS was activated to active duty under the presidential authorization to call up members of Air Force Reserve Command in support of Operation Iraqi Freedom. Although the reservists will not continually rotate in and out as a squadron, according to Sergeant Wright, they will continue to support (air and space expeditionary force) missions as needed.

## Preparation Eliminates Heartache

I lost a friend of many years; she passed away earlier this week from injuries sustained in a house fire. While this is a very sad situation it was made more difficult by a lack of preparation and the chain of events that follow a tragedy such as this. As an Air Reserve Technician she had taken the first step in preparing for her death, she had a will. It was prepared in 1999. She was divorced -- her only child was grown, so things seemed somewhat simple. The situation got complicated at the hospital when she was placed on life support. Important questions were asked. Did she have a living will? If so where was it? Could she have a safety deposit box? What about organ donation? Her 21 year old daughter had to answer these questions. Friends searched her office and burned home for important documents.

No one wants to think about their death or the death of a

loved one, but I urge you all to take a few minutes and make things a little easier on those left behind. Make sure you have a will, keep it current and get a safety deposit box for your valuable papers. Often papers stored at home are destroyed in a fire, flood or they are just impossible to locate.

Recently there was a case in the news regarding parents fighting over the final disposition of remains of a soldier killed in Iraq. His parents were divorced and lived in separate states; because the soldier had made no written declaration regarding his burial, a fierce legal battle ensued. Imagine dealing with the death of a child and then fighting about where the child was to be buried. Based on the fine print in some DoD directive, the decision was ultimately made to give the remains to the soldier's father because he was the eldest of the two parents.

To prepare for your family I suggest as a minimum the following:

Make sure you have a will, and keep it current. Set up trusts

for your minor children if applicable. Have a living will. Write down your desire to be buried or cremated, and what you want done with your remains. Make decisions about organ donation and accomplish necessary election.

Review information on the following Department of Veterans Affairs Website, [www.vba.va.gov/survivors/VABenefits.htm](http://www.vba.va.gov/survivors/VABenefits.htm), make note of information and discuss with your spouse.

Visit this link off the Air Force Personnel Center website, [www.afpc.randolph.af.mil/casualty](http://www.afpc.randolph.af.mil/casualty), complete the "Retiree Checklist" located to the right of the page for yourself and your spouse. It is a useful tool not just for retirees. Add any additional information that pertains to you and your family to your checklist.

Go to the Air Force Website, click on the link for library/publications, read AFI 36-3002, Casualty Services, Chapters 4, 6, 7 and 8.

Your family will appreciate this active and proactive demonstration of your love.

## Dobbins opens new medical clinic

The simple cutting of a ribbon ushered in a new era for the 94th Aeromedical Staging Squadron.

Brig. Gen. Thomas Stogsdill, 94th Airlift Wing commander, and Col. Edith Schafer, 94th ASTS commander, cut the ribbon to the newly renovated building for the unit.

The squadron that is almost as old as the Air Force itself, originally standing up in 1947 as one of the oldest Air Force Reserve medical squadrons has seen it's share of changes and moves.

After just a brief stint in Mississippi during the 1960s, the unit returned to Dobbins then known as the 918th Tactical Hospital. Its mission was as a second echelon medical care unit and operated out of Quonset huts.

In the 80's the unit changed to the 94th Medical Squadron with approximately 50 Airmen serving under the command.

A new addition to the Navy dispensary was their home in the 90s. Although the addition was

built for the Air Force they had to share the building and facilities with the Navy. This was sometimes a challenge meeting the demands of physicals and the needs of the clinic and its customers.

The unit did their part in Desert Shield when the unit activated 93 people to serve as part of the 94th Medical Squadron.

In 2000, the unit made one more temporary move to the hanger in building 838 before finally moving into their new home in building 922.

Maj. Gen. Howard McMahon, Air Combat Command Surgeon General IMA and a former commander of the unit, attended the ceremony and remarked that he was proud to be a part of this outstanding unit.

With the move to the new building, the unit hopes to see improvements in the service they offer. According to Col. Louis Miller, 94th ASTS, the new clinic will allow them to go back to doing physicals on Saturdays and utilize Sundays to complete the important administrative processing.

away, my film is about a successful playwright, Dajero, who has contracted a life threatening illness through living a careless lifestyle," said Airman Brown.

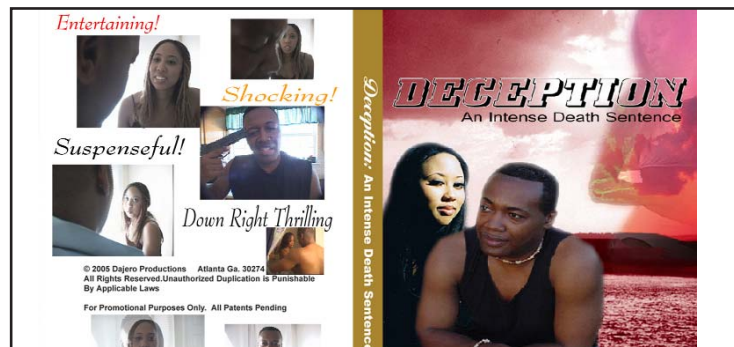
The story follows him through his last days as he argues with his friend about his condition. The film is raw and honest, he added.

## Malicious intent

Air Force users have continued to be targeted by specially crafted malicious emails. These emails contain Trojan attachments and use deceptive subject lines and return addresses to entice their targets to open the emails. DOD networks of these targeted accounts should be considered a risk for compromised hosts and Trojan backdoor activity. If current anti-virus software does not detect and quarantine the Trojans, the potential for an infection is great. Several of the emails have return addresses designed to make the emails appear to originate from official government offices. Consider the following as you manage your email: Do you know the person/address that sent the email? Is there a reason for you to receive email from that address? Would you expect the sender to use the subject identified in the email? Does it make sense that you would receive an email on the topic? Does it contain an attachment or hyperlink? Does the attachment title match the subject of the email? For more information, call the Dobbins Helpdesk at 678-655-4589.

# Dobbins Police Blotter

## Traffic accident

Dispatch received a call from security that a vehicle struck the fence on Highway 280. A security patrol was briefed, dispatched and, upon arrival, reported that an accident occurred with no injuries. The security patrol reported that a person at the scene stated he lost control of his vehicle and struck the fence. Damage to the front of the vehicle was severe. A Cobb County Police officer also investigated the accident.

## Medical response

94th Security Forces received a call from the Fire Department requesting a assistance with an Air Force member complaining of chest pain. Security briefed and dispatched a patrol. Fire Department dispatch notified Security Forces of the termination of the medical response. The service-member was transported to Kennestone Hospital.

## 911 prank call

The Dobbins Fire Department dispatcher notified security of an incoming 911 call, stating that there is an individual in the area of the BX, CE, Fence line requesting emergency response. The dispatcher requested an escort for Fire Department personnel from Security Forces. Security was briefed and dispatched to the location of Industrial Drive near the transformer across from the BX. Security officers reported that the 911 call was

believed to be a prank. Security Forces reported that stated that a call from Navy Exchange came in at the same time and the dispatcher had gotten the two calls mixed up. The Security Forces commander contacted the Fire Department dispatcher to verify the information, which she confirmed. The emergency response was terminated.

## Suspicious activity
