## Week of February 21, 2012

#### **Upcoming Events** February 23: Connecting Communities for the Common Good Conference

On Thursday, February 23,HUD's Center for Faith-Based and Neighborhood Partnerships and the White House Office of Faith-Based and Neighborhood Partnerships will host the "Connecting Communities for the Common Good" Conference in Portland, Oregon. Joshua DuBois, Executive Director of the White House Office of Faith-Based and Neighborhood Partnerships, will facilitate a panel discussion with the Departments of Homeland Security (DHS); Justice (DOJ); Health and Human Services (HHS); Agriculture (USDA); and HUD. Center representatives will present on how the federal government is working with faith-based organizations to serve those in need, as well as available federal resources for various service programs.

In the afternoon, the HUD Center will facilitate a capacity building training for attending nonprofit representatives. Participants will learn the key elements of how to prepare and compete for federal funding streams, how to understand the grant application process, and the important factors for award. Attendees will also learn about CPD, FHEO, and Housing programs and how they are being utilized in the Portland area.

#### Week of April 2, 2012

Pastors and the White House Partner for the Common Good; White House Office of Faith-Based and Neighborhood Partnerships and the SBA Host Economic Recovery Symposium



On Friday, March 23, the White House Office of Public Engagement convened a meeting of 150 African American faith leaders from around the country to discuss issues of concern to pastors and their congregations. Joshua DuBois, Executive Director of the White House Office of Faith-Based and Neighborhood Partnerships, and Paul Monteiro, Associate Director of the White House Office of Public Engagement, welcomed the group. Following opening remarks, Secretary Donovan, Education Secretary Arne Duncan, and Attorney General Eric Holder discussed the top priorities and accomplishments in education, housing, and justice.

During the afternoon, HUD Center for Faith-Based and Neighborhood Partnerships Director Paula Lincoln facilitated a panel including presenters from HUD, Treasury, and the Consumer Financial Protection Bureau. The audience received invaluable information about the mortgage servicing settlement, foreclosure scam prevention, and the President's plan to help homeowners refinance. The daylong briefing concluded with President Obama addressing the delegation in the White House South Court Auditorium highlighting the Administration's accomplishments over the last three years.

Also last week, the White House Office of Faith-Based and Neighborhood Partnerships partnered with the U.S. Small Business Administration (SBA) to host a "Symposium to Address Economic Recovery Through Strong Communities and Job Creation" at Norfolk State University, in Norfolk, Virginia. Joshua DuBois welcomed some 200 attendees to the symposium. Keynote Speaker Marie Johns, SBA Deputy Administrator, moderated a plenary panel consisting of representatives from the Virginia District Small Business Administration, the Departments of Labor (DOL); Veterans Affairs (VA) and Treasury's Offices of IRS and Training and Outreach for Faith-Based and Neighborhood Partnerships.

Following panel, attendees participated in concurrent workshops led by SBA, DOL, VA, Treasury, HUD, Education, and Justice. HUD's presentation, "Foreclosure: Where to Turn when you Don't Know where to Turn," was moderated by Anne Davis, Senior Management Analyst, of HUD's Richmond Field Office with panelists Kelly Gill-Gordon, Home Ownership Education Coordinator for the Virginia Housing Development Authority and Dotty Acompora, Comprehensive Certified Housing Counselor for the Virginia Beach Community Development Corporation. The panel discussed FHA and other resources that will help prevent and resolve these serious issues affecting America's economic recovery.

# Center for Faith-Based and Neighborhood Partnerships Presents at the Hispanic Pastors Association Faith-Based Outreach Event in Orlando

On Thursday, March 29, representatives from the HUD Center for Faith-Based and Neighborhood Partnerships (CFBNP) met with more than 70 Hispanic pastors and community leaders from Osceola, Orange and Lake Counties, three rapidly growing areas in the Central Florida Orlando Tri-County area. Pastor Javier Figueroa, President of the Pastors Association, organized this historic meeting at Centro de la Familia Cristiana de Poinciana, located in Kissimmee, Florida. After a capacity building workshop, there was an open discussion on issues facing non-profit organizations, faith leaders and their constituents as they relate to regional needs such as housing development, foreclosures, healthcare, jobs and immigration. Fred Washington, HUD Tampa, provided information on ways to build organizational capacity within churches and non-



profit organizations. HUD CFBNP Director Paula Lincoln highlighted key points on the mortgage servicing settlement and discussed techniques to prevent scams, and BJ Douglass, Senior Project Officer, answered questions about how faith-based and community organizations can access HUD resources and opportunities. Callers will learn about the mortgage servicing settlement, the new FHA Streamline Refinance MIP options available to eligible homeowners, scam awareness and prevention efforts, and the importance of using HUD-approved Housing Counselors from senior HUD officials including HUD Secretary Shaun Donovan. Faith and community leaders will receive information and resources they can use to help congregation and community members facing foreclosure and/or families who might qualify for compensation due to an improper foreclosure practices, mortgage principal reductions and refinancing of underwater homes available for eligible homeowners. 

#### Closing the Gaps: New Mexico Tribal Infrastructure Conference

The HUD Center for Faith-Based and Neighborhood Partnerships led the "Closing the Gaps: New Mexico Tribal Infrastructure Conference" on May 30 and 31 at the Indian Pueblo Cultural Center in Albuquerque, New Mexico. Derrith Watchman-Moore, HUD Region VII Regional Administrator and the Secretary's Policy Advisor for Tribal Affairs, offered the keynote address, entitled "Planning, Execution, Management and Sustainability in Critical Infrastructure Projects."

The Center also delivered its signature Capacity Building and Grant Writing Training to tribal grant writers during the conference, offering valuable information in understanding the grant proposal from the funder's perspective, among other important topics. The Center offered the conference in collaboration with Arthur Allison, New Mexico's Secretary of Indian Affairs, and was assisted by Office of Native American Programs Administrator Carolyn O'Neil and her staff, as well as Albuquerque Field Office Director Elise McConnell. At the end of the conference, attendees had the opportunity of meeting with state, federal and private funders and technical assistance providers.

## **HUD Center for Faith-Based and Neighborhood Partnerships at the National Baptist Convention—Congress of Christian Education**

The Faith-Based Center participated in the annual National Baptist Convention (NBC) with an estimated 25,000

participants from all over the United States. The Center staffed a booth in the Convention Exhibition and distributed several thousand copies of information to participants, pastors and ministers. Distributed fact sheets included information on foreclosure prevention, scam awareness, the national mortgage settlement, the independent foreclosure review, as well as other HUD programs. The Center also conducted a Federal Partnership Learning Workshop for 50 NBC faith liaisons to discuss HUD programs and opportunities to partner. The Center looks forward to future meetings with the National Baptist Convention and the NBC faith liaisons.

#### Farmers Market—Food Desert



#### **Recognizing Signs of Human Trafficking**



Last week, President Obama gave a landmark speech at the Clinton Global Initiative Annual Meeting about new initiatives to fight against human trafficking. The Administration is taking new steps to combat the exploitation of workers and children in the United States and abroad through the recently issued Executive Order which strengthens prohibitions against human trafficking in government contracting, making it applicable to all federal contractors and subcontractors. The new rules also require compliance

for large overseas contracts and subcontracts. The Administration is also providing more training on human trafficking to federal prosecutors, law enforcement officials, immigration judges and others.

In conjunction with the President's speech, the HUD Center for Faith-Based and Neighborhood Partnerships released a fact sheet about human trafficking. Though HUD has no enforcement authority or program responsibility in this area, the HUD Center is sharing this information to raise awareness about the issue. You and members of your community can play an important role in identifying and ending human trafficking.
