#### **Radio Talk Shows**

The HPNS cleanup team knows that everyone cannot come to meetings. Based on information received during the CIP interviews, community members said that radio would be a good way to communicate. The Navy had the opportunity to appear on two local radio shows during the Fall of 2011, KSQC/KVTO (96.1FM & 1400AM) and KIQI (1010AM).

### **Shipyard Bus Tours**

Comments made during CIP interviews made it clear to the HPNS cleanup team that people do not just want to hear about the cleanup; they would like to see what is going on so that they can better understand it. Bus tours of cleanup sites were said to be a good way to get interested community members out to the sites. The Navy held bus tours on August 26 and 27, 2011.

# **Document Review**

At certain times during the cleanup process, technical reports are written that can be reviewed by the public. The Proposed Plan for HPNS Parcel E-2 was released in September 2011 and an extended public comment period was held from September 20 through November 21, 2011.

The HPNS cleanup team includes the Navy, the United States Environmental Protection Agency, the California Department of Toxic Substances Control, and the San Francisco Bay Regional Water Quality Control Board.

In 1988, the Department of Defense created the Base Realignment and Closure (BRAC) Program to oversee the cleanup and transfer of military bases to public or private groups for redevelopment.

HPNS was added to the BRAC Program in 1998, and the Navy has been working since that time to clean up hazardous waste created by former shipyard use.

### **Outreach Updates**

Part of the Annual Overview includes the major cleanup activities at HPNS for the coming year. As schedules change, the HPNS cleanup team will create update flyers that will help community members see what has been done over the past several months, and what type of community outreach is planned for the coming months, including public documents for review.
